## Business Parking Permit Application



- Business Parking Permits allows the motor vehicle displaying the permit to overstay the time limit in a time restricted
  parking area (2 hour or greater) except for the exclusion zones listed at <u>unley.sa.gov.au/Business-Parking-Permit</u>
- They are not permitted to be used in Resident Only Permit Zones or Mobility Access Permit zones
- The permit(s) will be transferable, and the permit must clearly displayed on the vehicle parked in the zone at all times.
- The holder of a Business Parking Permit is not guaranteed a parking space.
- Business parking permits will be granted for a maximum duration of twelve (12) months.
- A maximum of two (2) business parking permits can be issued to a business.
- · Permits will be issued in the Business name only not individuals

# Business Parking Permit Application



### **Conditions of Use**

- 1. Permit must be affixed to the front windscreen or dashboard on the passenger side of the vehicle so that the entire permit is clearly visible from outside of the motor vehicle.
- 2.A permit will not allow the holder to contravene any other breaches or provisions of the Road Traffic Act 1961, the Australian Road Rules 1999 and Council By-Laws in relation to the stopping or parking of motor vehicles. This includes use of a permit on an unregistered motor vehicle.
- 3.If an expiation notice is received, a written submission to Council is required for the expiation notice to be reviewed. Failure to display a valid permit is not in itself a reason for Council to waive an expiation.
- 4. "Time Limit zone" allows the motor vehicle displaying the permit to overstay the time limit in a time restricted parking area (2 hour or greater).
- 5. They are not permitted to be used in Resident Only Permit Zones or Mobility Access Permit zones.
- 6. They are not permitted to be used on state arterial roads, King William Road, or Council owned and operated offstreet carparks. To view the full list of permit exclusions please visit <u>unley.sa.gov.au/Business-Parking-Permit</u>
- 7. Council may, by notice in writing, cancel a permit for a breach of a condition.
