Motion:

The National General Assembly calls on the Australian Government to pursue compulsory voting in local government elections for all States and Territories.

National Objective:

Compulsory voting and the importance to local government.

Compulsory voting for national elections was introduced in Australia in 1924, following a pronounced fall in turnout at the 1922 federal election. Compulsory enrolment had already been introduced in 1911. Voting is also compulsory at state level, having been introduced in Queensland in 1915, Victoria in 1926, New South Wales and Tasmania in 1928, Western Australia in 1936, and South Australia in 1942.

However, despite consistently low voting in local government elections in States and Territories where it is voluntary - no change has been proposed. South Australia, the Northern Territory and Western Australia remain the only jurisdictions in Australia not to have compulsory voting in Local Government elections.

Summary of Key Arguments:

Compulsory voting has many benefits. It increases the legitimacy of elected representatives as they must win an actual majority of electors. Voting is a necessary part of civic duty and will increase the interest in council activities. Compulsory voting ensures that the influence of pressure groups is in proportion to their actual support throughout the community and it allows elections to focus purely on the issues, not the extent of turnout.

South Australia (and the Northern Territory and Western Australia) are lagging behind the eastern states when it comes to participation in democracy. Despite moving to a postal voting system in South Australia, participation still flutters around 30%, hardly a true community representation. This motion calls on the Australian Local Government Association to advocate for and promote a standardised compulsory voting system in all Australian local government jurisdictions.

The following Questions on Notice were received from Councillor S. Dewing and the answers are provided:

QUESTIONS

- 1. What current capacity does Council have to address concerns by residents relating to large developments?
- 2. Are there resource implications arising from the new Planning & Development Code in order to address the concerns of and impacts on residents?

ANSWERS

Preamble

In response to Councillor S. Dewing's motion on notice (Item 5.1.3) at the Council meeting of 22 June 2020, Elected Members were provided with a presentation giving an overview of resourcing arrangements to respond to community concerns relating to the construction and impact of major developments. This presentation included preliminary service level and resourcing options and a commitment was given to prepare a report outlining the future approach following the completion of the Development Services review and implementation of the Planning and Design Code. This is anticipated to be completed by April 2021.

1. What current capacity does Council have to address concerns by residents relating to large developments?

Council currently does not have a single resource that responds to concerns relating to major developments. Instead, these functions are undertaken in collaboration across the organisation including:

- Policy Planning providing input into the SCAP Development Assessment process which gives us an opportunity to flag local impact and planning concerns and considerations prior to approval of the development.
- Traffic Management consideration of traffic controls to facilitate construction and manage ongoing traffic flow and parking requirements post construction.
- Parking Enforcement monitoring and managing compliance of on street parking within the prescribed traffic controls and legislation.
- Permits issuing and management of related permits, such as hoarding and parking during and post construction.
- Asset Management public realm, waste, infrastructure, encroachments and environmental impacts of development including damage to Council infrastructure (includes trees).
- Building Compliance responding to construction impacts including noise, nuisance and hours of operation.

The main difficulty with these large-scale developments is that the value and scale of the development requires the approval of the State Commission Assessment Panel. In these instances, Council has little power to influence or enforce planning requirements, with much of our effort directed at nuisance and litter, parking compliance and infrastructure matters relating to construction. We are aware that Elected Members receive significant contact from residents related to issues associated with developments of this scale, and their ability to respond in a manner that addresses residents' concerns is also constrained.

Within existing resources, council officers liaise with developers and their representatives to raise and resolve issues that impact the local area and community. It is noted that as there are currently only a small number of these major developments happening within the City of Unley, additional resourcing is not required at this time.

In response to the previous Notice of Motion, a report will be brought back to Council in April 2021 outlining options and costs.

2. Are there resource implications arising from the new Planning & Development Code in order to address the concerns of and impacts on residents?

Implications under the new Planning and Design Code will remain consistent to those currently experienced under the Development Act.
